Steps

Steps to Earn Your Endangered Species Patch:

- 1. Complete activities from the Discover, Connect, and Take Action sections.
- 2. Order your patch!

Discover

- Research the process of how an endangered species is <u>listed</u> on the ESA? What is the difference between endangered and threatened? How do we know when an endangered species has recovered?
- Research other conservation laws and methods. How are they similar/different from the ESA?
- Explore environmental careers! (Here's a few to get you started: climatologist, environmental writer, zoologist, hydrologist)
- Investigate local, regional, and global species that are threatened or endangered.
- Explore, hike, and tour natrual areas and learn about wildlife habitats.

Connect



- Watch a documentary concerning our environment.
- Develop an endangered species board game and include as many species as possible. Share and play your game with other Girl Scouts or classmates!
- Create an Infographic. Think of five things you could do to enhance the public's understanding of endangered species in your community.
- Meet a staff biologist, site manager, or research scientist and learn how they help preserve wildlife environments.
